



IB Referral 30% Deposit Bonus Promotion

Terms and Conditions
Eightcap International



GENERAL

1. The promotion is offered by CLMarkets Limited, trading as Eightcap International, a company providing trading in financial, and commodity-based derivative instruments and other securities, registered in Saint Vincent and the Grenadines, (Registration No 24750 IBC 2018).
2. This promotion is exclusive to selected clients (Selected Clients). Selected Clients are those who meet the criteria detailed herein.

PROMOTION DETAILS

3. A Selected Client shall receive a Deposit Bonus equal to 30% of their Original Deposit, up to the maximum amount of \$500 USD (or equivalent currency).

ELIGIBILITY CRITERIA

4. To be eligible for this promotion, Selected Clients must:
 - a. Have opened a live trading account (Account) with Eightcap International;
 - b. Be a registered referral under an approved IB number with Eightcap International;
 - c. Deposit a minimum of \$100 USD (or equivalent currency) and up to a maximum of \$1,650 USD (or equivalent currency) (Original Deposit) into their Account.

CONDITIONS

5. The Deposit Bonus:
 - a. Shall only be credited to the Selected Client's Account once the Original Deposit has been made. This may take up to 24 business hours to be added into the Selected Client's Account (subject to approval);



- b. Shall appear in the balance facility of the trading platform and shall form part of the Selected Client's Account equity;
- c. May be used for trading purposes only (as margin to open and maintain positions) and CANNOT be withdrawn as cash;
- d. May be redeemed ONCE only (available once per Selected Client and not once per Selected Client Account);
- e. Shall be subject to removal if there has been no trading activity in the Account for a period of two or more months.

6. The Deposit Bonus can be used to increase a client's margin but cannot be lost in trading. In the event that a Selected Client's equity reaches or falls below the level of the Deposit Bonus, the bonus will be automatically removed from the client's account.

7. The Deposit Bonus is non-transferable between the trading accounts or persons and cannot be combined with any other promotion or offer.

8. A Selected Client may choose to withdraw their Original Deposit at any time, provided their Original Deposit has not been lost in the course of their trading activity or is being used as margin.

9. The withdrawal of a Selected Client's Original Deposit from their Account will immediately result in the Deposit Bonus being voided. Once the Deposit Bonus is voided, it cannot be used as a margin to open and maintain positions or for any other purpose. For a partial withdrawal, your available Deposit Bonus will be calculated pro rata based on the balance of the trading account.

10. In the event of the Net Equity on a Selected Client's Account being less than or equal to the Deposit Bonus, the Selected Client may (with or without warning) lose the Deposit Bonus. This may result in your positions being closed. Further, Eightcap International may in its discretion remove the Deposit Bonus and/or close out any open positions. The company accepts no liability whatsoever for any loss resulting from the Stop Out of open positions where the Company has removed the Deposit Bonus.

It is always the Selected Client's responsibility to ensure that the Net Equity of their Account does not fall below the Deposit Bonus awarded to them under this promotion.

11. Eightcap International reserves the right to withhold or void without further notice the Selected Client Deposit Bonus if in its reasonable belief, there is any indication or suspicion of any form of arbitrage (including but not limited to risk free profiting), abuse (including but not limited to a Selected Client's trading activity patterns that indicate that the Selected Client solely aims to benefit financially from the Deposit Bonus without being genuinely interested in trading the markets and/or taking market risk), fraud, manipulation, cash-back arbitrage connected to a trading bonus or any other form(s) of deceitful or fraudulent activity or behaviour.

12. These Terms and Conditions must be read in conjunction with the Eightcap International legal documents. In the event of a conflict between these Terms and Conditions and the Eightcap International legal documents, the legal documents shall prevail.

13. Participation in this promotion signifies acceptance of all Terms and Conditions referenced herein. Selected Clients are required to abide by all Terms and Conditions as presented, at all times.

14. Eightcap International's decision relating to any aspect of this promotion shall be final and binding.

15. This promotion is not available to residents of Australia, USA, Pakistan, Russia, Belarus, Ukraine or any other restricted jurisdiction.

JURISDICTION

Deposit Bonus	Means the account trading credit deposited by us into a Select Client's Account, in accordance with clause 3 of these terms and conditions.
Net Equity	Means the account balance including (after) any unrealised profit and/or unrealised loss on open positions. Net Equity is an indication of the overall performance of an Account, as it considers the Account balance and how each individual position is performing.
